

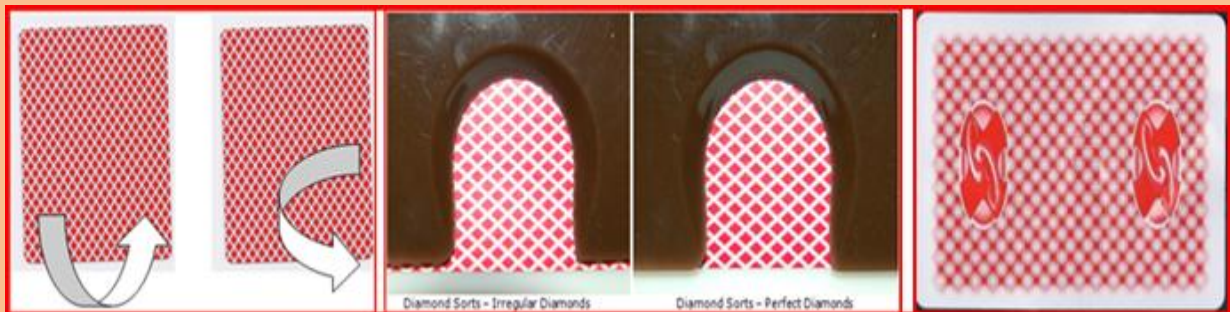

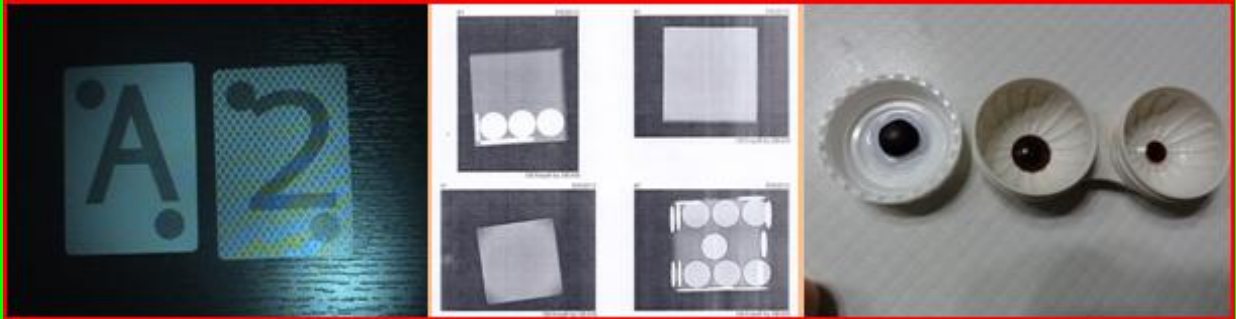

Mr. Joseph has been instrumental in uncovering many of the biggest casino scams in the gaming industry and has been a consulting investigator and expert witness in countless casino cheating prosecutions for over thirty years. I'm *"Preaching to the Choir"* when I point out that Surveillance is the only department in a Hotel/Casino who needs to know every other department's SOP's & P&P's. (A 21 Dealer doesn't need to know Cage policies or procedures, a Slot Manager doesn't have to understand Food & Beverage, none of the above ever watches the Count Room or Meat Locker)...But Surveillance is charged with knowing & watching & investigating every revenue generating department, threat to bankroll and "Inventory Leakage" which could occur throughout the entire property. This element of training explores Cage, Count Room, Point of Sale and Back of the House issues.
